## **Session One Presenter Biographies**

**Dani Levesque** (she/her), Victims Service Specialist, Vermont Department of Corrections Dani has been with VT DOC for 5 years providing post-conviction victim services in the Northwest region of the state. Before that Dani worked for many years at what used to be called the Women's Rape Crisis Center, now Hope Works, in Burlington. She provided legal advocacy, coordinated and facilitated support groups, covered innumerable hotline shifts and mowed the lawn.

**Vicki Garza, RN** is the Sexual Assault Program Coordinator at the Vermont Center for Crime Victim Services (VCCVS). She joined VCCVS in April of 2017 after spending the previous 22 years practicing as a Registered Nurse in both inpatient and outpatient setting, including four years of active duty service as a Navy Nurse Corp Officer. **Ultan Doyle** has been an Assistant Attorney General in the VT Attorney General's Office since 2010 where he prosecutes and reviews serious felony cases. He has been an assistant attorney general since 1987 and has spent most of his public service career prosecuting crimes of sexual and physical abuse against children and vulnerable adults.

**Linda Purdy** is an Assistant Attorney General & Director, Medicaid Fraud & Residential Abuse Unit within the Office of the Vermont Attorney General. We prosecute criminal and civil Medicaid provider fraud cases and also investigate and prosecute cases of abuse, neglect and exploitation of elderly and vulnerable adults in residential settings, including nursing homes. In the past, Linda I was the Director of the Child Protection Unit, Chief of the Human Services Division and prosecuted cases of termination of parental rights in juvenile court. She was also an adjunct Professor at Vermont Law School for fifteen years teaching trial practice.

**Michelle Pelletier** is currently the Collection Supervisor with the State of Vermont Restitution Unit, a program of the Vermont Center for Crime Victim Services. Prior to coming to the Center in 2005, Michelle worked as a Case Manager at Lamoille Restorative Center. She graduated from UVM in 2002 with a BSW.
